# TRIUMF - KAON Factory

Dr. Peter A. Larkin gave a brief progress report concerning the proposal from TRIUMF for a KAON Factory. The proposal had been reviewed by a joint committee of the National Research Council and the National Science and Engineering Research Council. The two Councils were impressed with the science, and thought it would be a wonderful thing for Canada, if Canada could afford it. It is seen by the review committee that there are a number of projects in Canada that might be funded for the same amount of money required to fund the KAON Factory. Dr. Erich Vogt, Director of TRIUMF, and Dr. Bruce Clayman, Dean, Faculty of Graduate Studies at SFU, had made a strong presentation to NRC on the proposal, and Dr. Larkin and Dr. Vogt hoped to make a presentation to NSERC at its meeting in January 1987.

## Funding for University Patents and Patent Search Service

Dr. Larkin was pleased to report that, under the Provincial Government's University/Industry Liaison funding scheme, the three public Universities have access to \$250,000 per year to pay patent charges on the basis that they will pay 25% and receive 75% from the \$250,000 fund. Dr. Larkin estimated that this will save the University about \$75,000 in 1986.

Under the same agreement, the University has received just over \$600,000 to establish a new service in the University Library to search out patent information. Dr. Larkin indicated that a primary source of patent information would be databases that provide basic information on the more than four million patents issued by the U.S. Patent Office and more than a million issued by the Canadian Patent Office.

Members of the press and the public gallery left the meeting.
